

ATRF 2022 Conference

Adelaide, 28-30 September

Flinders University - Tonsley Campus



We are pleased to announce that the 43rd Australasian Transport Research Forum (ATRF) will be held in **Adelaide, South Australia, 28 - 30 September 2022**. Although it is planned to be a face-to-face event (preferred format), to accommodate the possible impacts of further disruptions and limitations on movement and interstate travel, it is also proposed to stage the event virtually using the hybrid model, or even fully virtually, if State and Federal Government COVID regulations restrict interstate travel or the ability of the university to host the event.

ATRF has become a premier Transport Research forum in Australasia that seeks to maintain open dialogue among transport researchers, policymakers, advisors and practitioners, stimulating debate and forward-looking considerations of transport research across a wide range of subject areas.

Similar to 2021, this year's Call for Papers invites submission of **Research Papers** and **Professional Practice Papers**. This year, **Abridged Papers** will replace Extended Abstracts.

- The **Research Paper** stream is designed primarily for academics and professional researchers who want their work fully peer reviewed. Two reviewers will evaluate these papers based on the range of criteria commonly applied to scientific research works, particularly the extent to which the paper advances knowledge in the field or contributes to new fields. If accepted, these papers will be included in the ATRF Proceedings and cannot be submitted elsewhere if they contain more than 15% of the content submitted to ATRF. The page limit for Research Papers is 15 pages.
- The **Professional Practice Paper** stream is designed primarily for practitioners from government and the private sector. These papers are required to provide an insightful description of rigorous professional work associated with the administration, planning, design or operation of the transport system and the economic, social and environmental impacts of investments in transport infrastructure. Two reviewers will assess these papers from the perspective of their contribution to professional practice and government policy. Professional Practice Papers are expected to have relevance beyond the jurisdiction or organisation where the work was undertaken, and authors are encouraged to demonstrate the broader implications of their work. Papers must be free from obvious advertising or self-promotion. If accepted, these papers will be included in the ATRF Proceedings and cannot be submitted elsewhere if they contain more than 15% of the content submitted to ATRF. The page limit for Professional Practice Papers is 15 pages.

- The **Abridged Paper** stream is designed primarily for academics or practitioners who want to engage with the audience on their work-in-progress, receiving feedback to assist with the preparation of a full paper for archival journals or for their research as a practitioner. Abridged Papers will include the same sections as a full paper, without the details of a literature review or complete results and discussion. They will be reviewed with the same rigour applied to Research Papers and Professional Practice Papers. These papers will be included in the ATRF Proceedings, but the full paper can be submitted elsewhere in another format. The recommended length of Abridged Papers is 5-6 pages.

Templates for formatting submissions will be provided on the ATRF website and are also available through the EasyChair submission platform.

Topic Areas/Tracks

ATRF 2022 will cover a broad range of topics, including, but not limited to:

1. Traffic modelling, forecasting and simulation (including control and management)
2. Transport analysis and big data
3. Social, economic, and environmental effects of transport (climate change, air quality, and green/sustainable solutions)
4. Transport demand modelling (including scenario planning and analysis and risk management)
5. Travel behaviour change and demand management
6. Public transport
7. Active transport (cycling, walking, e-transport, etc.)
8. Transport and land-use (including urban design)
9. Transport economics, funding, pricing and appraisal
10. Aviation / Maritime transport and business continuity management
11. New vehicle technologies and innovative services (ITS connected and autonomous vehicles, MaaS, on-demand transport, e-scooters/e-bicycles, smart cities, etc.)
12. Freight and logistics, e-commerce, online retailing and supply chain resilience
13. Transport safety and security
14. Transport history
